

Soil Deposition Proposal Form

If your proposal involves the placement of fill within the Agricultural Land Reserve you are required to complete this form and submit it to the Commission. In answering the questions on the following pages Commission staff are able to determine if your proposal is exempt from an application, if it requires a notice of intent or if it requires an application. If your proposal does not qualify for exemption, an application for non-farm use to place fill or remove soil under section 20 of the Agricultural Land Commission Act is required.

The information required by this form and the documents you provide with it are collected to assess a proposal under the Agricultural Land Commission Act and regulation. This information will be available for review by any member of the public. If you have any questions about the collection or use of this information, contact the Commission and ask for the staff member handling the proposal.

Instructions:

Proposals to place fill must fall under one of the following categories in order to qualify for exemption from filing an application under the *Agricultural Land Commission Act*. Please check the appropriate box on the next page to identify if your proposal is for a specified use.

Although your proposal may not fit the criteria required to be considered a specified use it may still be considered exempt under certain circumstances. In order to assess these circumstances completion of Part 2 of this form is required.
